SURFACE RIGHTS BOARD

BOARD ORDER

The Applicant, Husky Oil Limited, requires access to the Lands legally described as: THE NORTH WEST ¼ OF SECTION 36 TOWNSHIP 81 RANGE 14 WEST OF THE 6TH MERIDIAN PEACE RIVER DISTRICT, owned by the Respondent, Roy Ralph Juell, for an oil and gas activity, specifically to construct, drill and operate a well known as HUSKY MICA 14-36-81-14W6M, for which the Oil and Gas Commission issued a permit on July 24, 2012. Right of entry is not opposed and compensation payable by the Applicant to the Respondent for entry, occupation and use of the Lands is agreed.

BY CONSENT the Surface Rights Board orders:

1. Upon payment of the amount ordered in paragraph 2, the Applicant, Husky Oil Operations Limited, shall have the right of entry to and access across the portion of the Lands shown in Appendix "A" for the purpose of construction, operation and maintenance of a well known as HUSKY MICA 14-36-81-14W6M in accordance with a permit issued by the Oil and Gas Commission on July 24, 2012 (WA 28390).
2. The Applicant, Husky Oil Operations Limited, shall pay to the Respondent, Roy Ralph Juell, the sum of \$12,000.00 as initial compensation for access to those portions of the Lands required to construct, drill and operate the well known as HUSKY MICA 14-36-81-14W6M prior to commencement of construction.
3. The applicant, Husky Oil Operations Limited, shall pay to the Respondent, Roy Ralph Juell, the sum of \$4,200.00 as annual compensation for the occupation and use of those portions of the Lands required for the operation of the well known as HUSKY MICA 14-36-81-14W6M.
4. Nothing in this order operates as consent, permission, approval or authorization of matters with the jurisdiction of the Oil and Gas Commission.

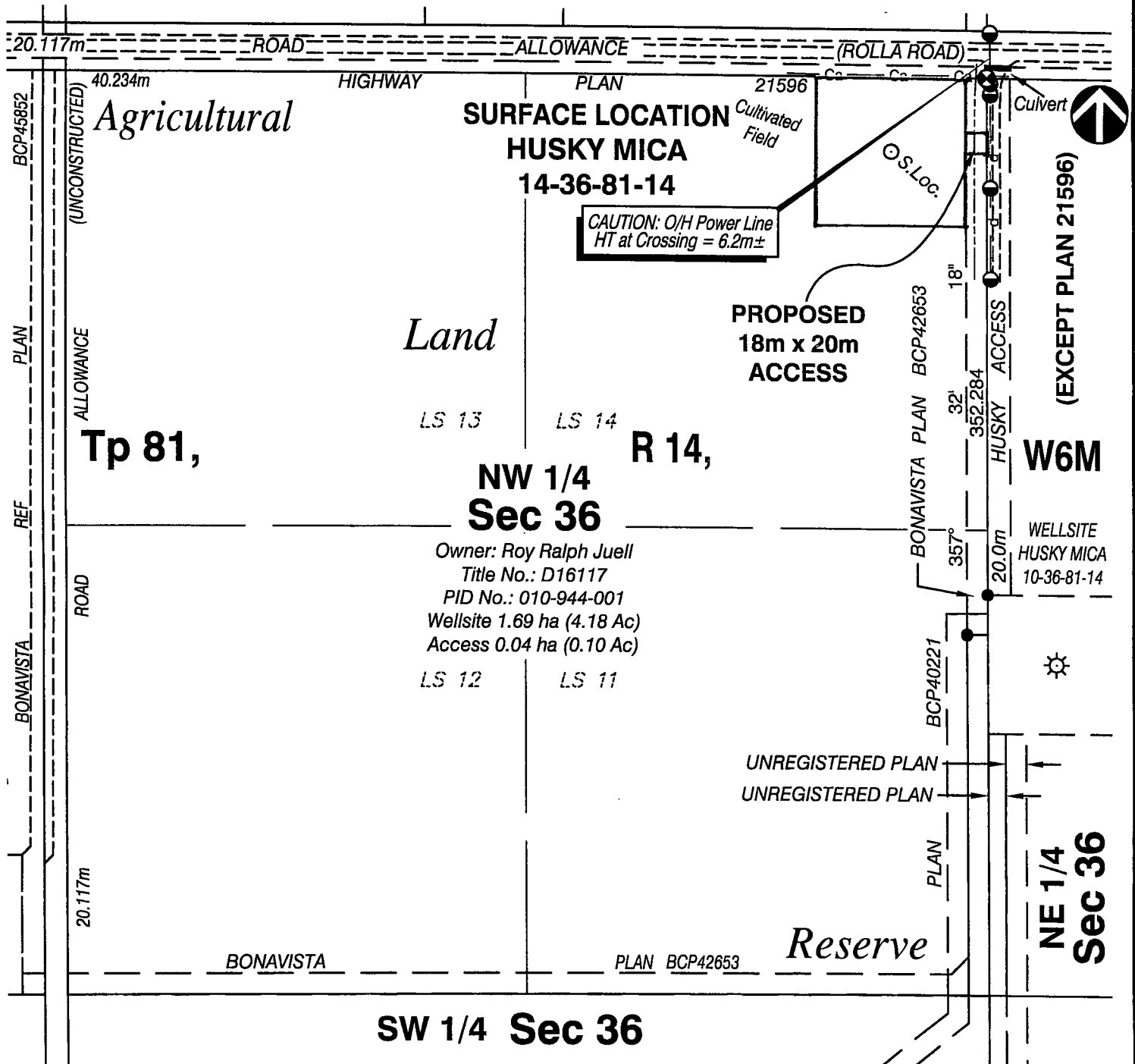
INDIVIDUAL OWNERSHIP PLAN
